American Riviera Figure Skating Club (ARFSC) Membership Information

Membership Term: Memberships are valid from July 1st of one year to June 30th of the following year. This is in order to synchronize with the membership term of United States Figure Skating (USFS) that we are affiliated with. If a membership is submitted anytime between July 1st and June 30th it still expires on June 30th. This is a USFS policy that ARFSC cannot do anything about.

USFS Membership: Your home club membership at ARFSC also enrolls you as a member with full privileges in USFS. There is no need to separately register for USFS membership.

Membership Categories – First Family Member:

Home Club – This class of membership registers you with both USFS and ARFSC. It gives you full competitive and test privileges. It also comes with a subscription to “Skating” magazine – a publication of USFS.

Introductory – If you have never been a member of USFS through any club at any time in your life you can join at a discounted rate for your first membership term (see above). This class of membership gives you full privileges in both USFS and ARFSC. This class of membership was established by USFS in 2011.

Second Club – If you are already a member of USFS through another club this membership category allows you to participate in ARFSC events.

Professional – If you are a USFS registered professional and you wish your home club to be ARFSC then this is the class of membership you should use. Note: You will still need to pay your USFS professional insurance fees separately.

Collegiate – If you are a full time college student this membership allows you to enjoy full privileges in both USFS and ARFSC for 4 full years of college at one low price. This membership class was established by USFS in 2011. Note: ARFSC requests a new membership form each year so that we can update contact information.

Additional Family Members - If you have more than one person in your family who wishes to join discounted fees are available for those additional members. Additional family members must reside at the same mailing address as the first family member. The second family memberships do not include a subscription to “Skating” magazine, but afford all other privileges of both USFS and ARFSC.

Volunteer Opportunities - The American Riviera Figure Skating Club is a volunteer organization. All of the work that is done to support the skating community is done using volunteer labor on the part of club members. We can only support our skaters to the extent that our club community supports the club. You don't need to be an expert to participate, we can help to train you. We encourage volunteer activity in the following areas:

- Volunteer to help at a club event such as a test session, boutique sale or recital
- Participate as a non-elected member of the board: multiple positions are available
- Organize a club social activity

Skater's Code of Conduct

As a member of our club, all skaters, coaches, and parents must adhere to this Code of Conduct at all times.

General Guidelines:

The American Riviera Figure Skating Club is committed to creating a safe and positive environment for members' physical, emotional and social development and ensuring that it promotes an environment free of misconduct. This Skater Code of Conduct has been established to ensure the safety of all members using our ice to ensure quality practice time for all home club, associate, non-members and guests who purchase ice from the club and who participate in all club-related activities.

1. All skaters, regardless of whether they hold home club, associate, non-member or guest status, must follow and uphold the provisions in this Skater Code of Conduct regarding behavior on and off the ice. All club members are expected to exhibit good sportsmanship and be courteous toward their fellow skaters, coaches, parents/guardians of skaters, U.S. Figure Skating officials and guests.
2. The American Riviera Figure Skating Club is committed to promoting a positive and friendly environment for all skaters. Remember "The Golden Rule:" treat other people like you want to be treated — with respect.

US Figure Skating General Rule 1.03

"U.S. Figure Skating will not tolerate or condone any form of harassment (including sexual harassment), misconduct, (including sexual, physical and emotional misconduct), bullying or hazing of any of its members including coaches, officials, directors, employees, parents, athletes and volunteers — or any other persons — while they are participating in or preparing for a figure skating activity or event conducted under the auspices of U.S. Figure Skating."

Ice Etiquette and Safety:

1. While in lesson or practice, it is the skater's responsibility to always be conscientious and aware of other skaters around them.
2. Skaters must skate with the flow of other skaters and familiarize themselves with the most commonly used areas for jumps and spins.
3. The only time a skater has the SOLE right of way is when they are skating their program to music. When you hear another member's music, please extend that person the courtesy and move out of their path momentarily. This only takes a moment and you will enjoy the same courtesy while you are performing your program.
4. Advanced skaters are expected to exhibit patience toward beginner members of the club. Remember, you were an inexperienced skater once, and it takes time for our future generation to advance to the point where they are completely comfortable skating with all levels of skaters.

Unsafe or discourteous behavior of any kind will not be tolerated.

I acknowledge that if I believe event conditions are unsafe, I will immediately discontinue participation in the “activity”.

I fully understand that this “activity” involves risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my own actions, or inactions, those of others participating in the “activity”, the conditions in which the “activity” takes place, or the negligence of the “releasees” named below; and that there may be other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my participation in the “activity”.

I hereby release, discharge, and covenant not to sue the American Riviera Figure Skating Club, United States Figure Skating, its directors, officers, administrators, sponsors, volunteers, agents, employees, staff, instructors, trainers, other participants and if applicable, owners and lessors of premises on which the “activity” takes place (each considered one of the “Releasees” herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the “releasees” or otherwise, including negligent rescue operations; and I further agree that if, despite this release, waiver of liability, and assumption of risk, I, or anyone on my behalf, makes a claim against any of the Releasees, I will indemnify, save, and hold harmless each of the releasees from any loss, liability, damage, or cost which any may incur as the result of such claim.

The American Riviera Figure Skating Club has the right, but not the obligation, to provide rules, regulations and/or ice monitors for Club Ice. We hereby acknowledge that the American Riviera Figure Skating Club shall not be responsible for the supervision of the members at Club Ice.

I have read this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT, understand that I have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect.
